

PUBLIC HEARING NOTICE

NOTICE IS HEREBY GIVEN by the City of West Fork, Arkansas (the "City") that the West Fork City Council will hold a public hearing prior to the regular meeting of the City Council to be held at the West Fork Community Center located at 222 Webber, West Fork, Arkansas, on August 12, 2014 at 6:00 PM. The public hearing will be held for the purpose of considering an Ordinance establishing new rates for services rendered by the Water and Sewer System of the City of West Fork as follows:

That the following rates and charges are contained in the water/sewer rate ordinance introduced at the West Fork regular City Council meeting held on July 8, 2014.

MONTHLY WATER RATES TO BE EFFECTIVE AUGUST 14, 2014

1. For the first 2,000 gallons of water consumption per month, or portion thereof: \$13.50 Minimum
 2. For the next 3,000 gallons of water consumption per month, or portion thereof: \$6.75/1,000 gal
 3. For the next 45,000 gallons of water consumption per month, or portion thereof: \$6.15/1,000 gal
 4. For all water consumption in excess of 50,000 gallons: \$4.30/1,000 gal
- (a) Customers whose water connection is located outside the corporate limits of the City shall, in addition to the above charges, pay a monthly surcharge of twenty two dollars and fifty cents (\$22.50) per meter.
- (b) For water delivered to a portable tank truck there shall be a charge of \$12.50 per 1,000 gallons.

MONTHLY WATER RATES TO BE EFFECTIVE FEBRUARY 14, 2015

1. For the first 2,000 gallons of water consumption per month, or portion thereof: \$14.60 Minimum
2. For the next 3,000 gallons of water consumption per month, or portion thereof: \$7.30/1,000 gal
3. For the next 45,000 gallons of water consumption per month, or portion thereof: \$6.65/1,000 gal
4. For all water consumption in excess of 50,000 gallons: \$4.65/1,000 gal

- (a) Customers whose water connection is located outside the corporate limits of the City shall, in addition to the above charges, pay a monthly surcharge of twenty two dollars and fifty cents (\$22.50) per meter.
- (b) For water delivered to a portable tank truck there shall be a charge of \$12.50 per 1, 000 gallons.

MONTHLY WATER RATES TO BE EFFECTIVE AUGUST 14, 2015

- 1. For the first 2,000 gallons of water consumption per month, or portion thereof: \$15.75 Minimum
 - 2. For the next 3,000 gallons of water consumption per month, or portion thereof: \$7.90/1,000 gal
 - 3. For the next 45,000 gallons of water consumption per month, or portion thereof: \$7.20/1,000 gal
 - 4. For all water consumption in excess of 50,000 gallons: \$5.05/1,000 gal
- (a) Customers whose water connection is located outside the corporate limits of the City shall, in addition to the above charges, pay a monthly surcharge of twenty two dollars and fifty cents (\$22.50) per meter.
 - (b) For water delivered to a portable tank truck there shall be a charge of \$12.50 per 1, 000 gallons.

At the public hearing, all interested parties shall have at opportunity to be heard concerning the proposed new rates and Ordinance.
